
Before you start, make sure you have your:

- Citibank Banking ATM/Debit Card Number or Account Number
- E-mail or mobile phone available so we can send you a one-time registration code

 Go to Citibank® Online at citibankonline.com and select Register for Online Access ▶



- 1.2 Enter your Credit/Debit Card Number or Bank Account Number without any dashes or spaces
 - ► If your account is older than 14 days, we recommend using your Credit/Debit Card Number
 - Click on Continue Set Up



- 1.3 Enter the last four digits of your Social Security Number (SSN)
 - ▶ If you do not have a SSN, select the I don't have a Social Security Number checkbox and enter your Individual or Non US Foreign Taxpayer Identification Number (ITIN or FTIN) used to open the account
 - ► If you don't have an ITIN or FTIN, select the I do not have an Individual or Foreign Taxpayer Identification

 Number (ITIN or FTIN) check box and enter your Date of Birth (DOB) in the MM/DD/YYYY format
 - Click on Continue

- Once your SSN, FTIN, ITIN, or DOB is verified, you will be prompted to enter either your ATM PIN or complete a one-time passcode
- Click on Continue


- 2.1 Create a User ID and Password
